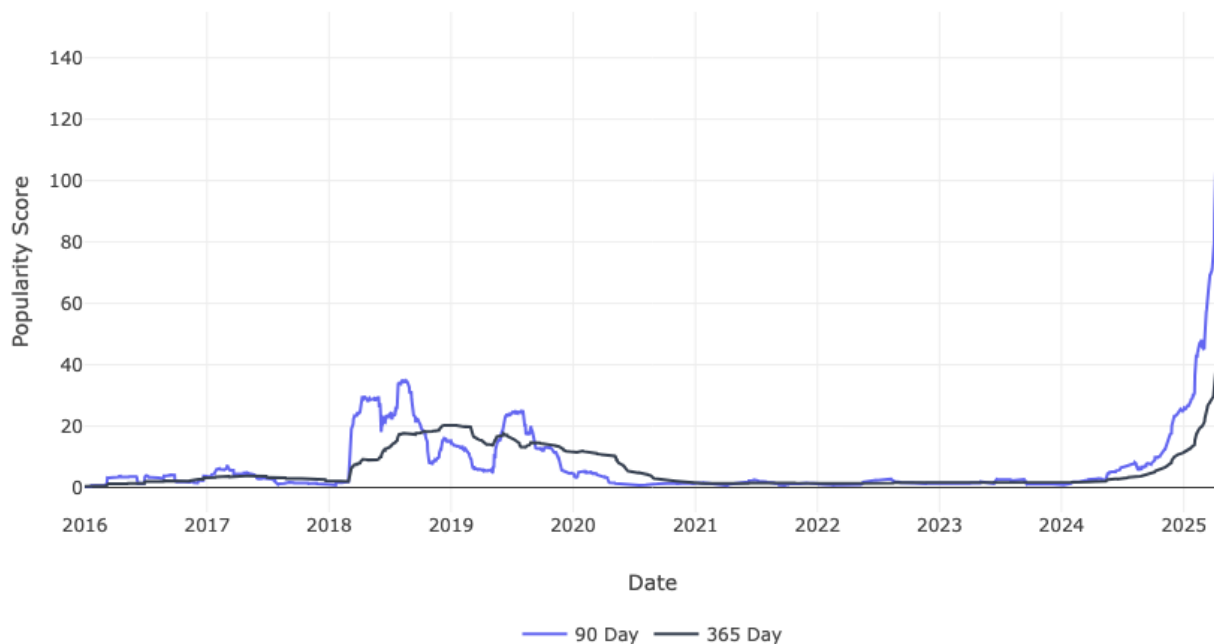

## 1. Tariffs, tariff, reciprocal, deficit

Tariffs were the most prominent talking point this week, with particular focus on the escalating trade tensions between the U.S. and China.

But first, today's PDB spotlight. The pressure from **President Trump's sweeping tariffs** is starting to hit home in China. At export hubs like Guangzhou and Shenzhen, see you didn't know I spoke Chinese. Factories are going quiet. Orders from US buyers are being canceled. Inventory is piling up and workers are bracing for layoffs.

And Friday, as you likely noticed, the stock market was closed for good Friday. On the week, the S&P 500 lost 1.5%, the Dow fell 2.7%, and the Nasdaq fell 2.6%. Dumping treasuries raises US borrowing costs and, more important, undermines global trust in American leadership. It also hurts China as a fire sale means they'll take losses too, and a possible recession hurts everyone. Beijing's fear of that economic pain has been a strong deterrent. Until now, **a trade war** makes the pain real, meaning China has a lot less to lose, and potentially something to gain, by using our debt against us. And China has a pain multiplier here, an increase of 50 basis points on a \$36 trillion debt adds about \$180 billion per year in additional interest.

It seems to me that at some point, you have to say that some technologies are just too sensitive to be sold to China. And so then the question is, is are you drawing the line in the right place? As well as this position that we're now going to make China force them to make their own chips.

*We've talked a lot about tariffs these last few weeks. And even in just those few weeks, things have changed a lot. So the latest started just after our last Friday news roundup went out. It was semiconductors, laptops, and cell phones among some other more technical things. And this was a real surprise because a lot of those electronic things that are excluded now come from China.*

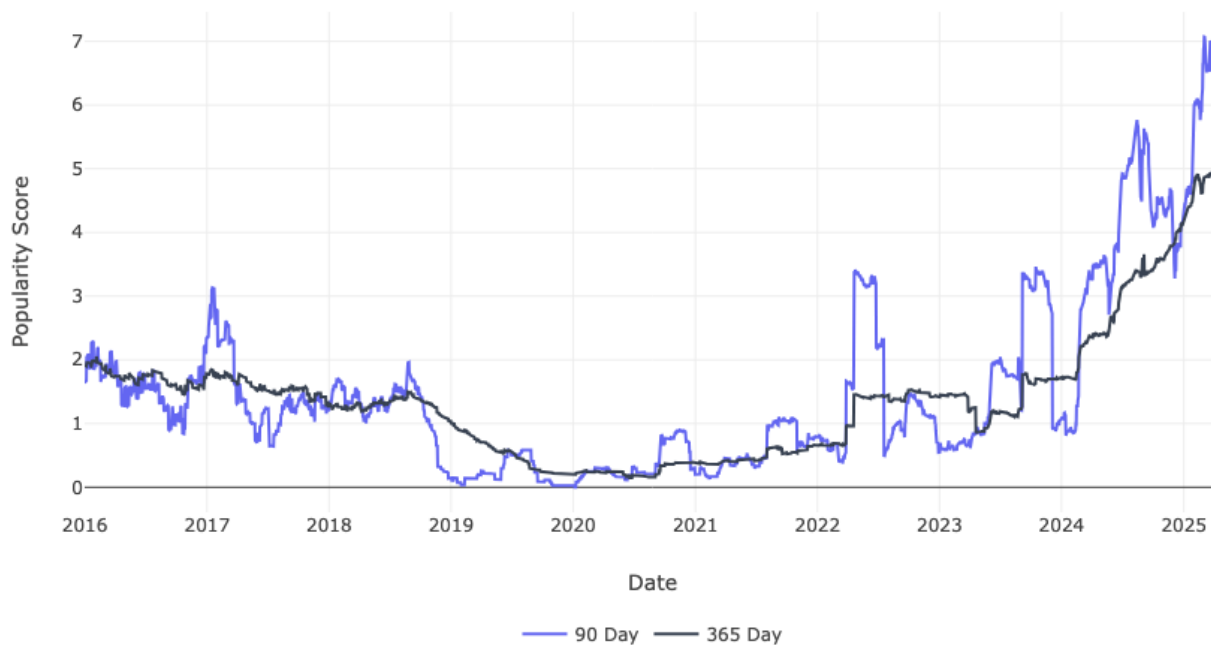

He's saying essentially that **the tariff war** is likely to drive up inflation, so it makes it harder for him to drop the interest rates. And he said he saw a strong likelihood that consumers would see higher prices and higher unemployment as a result of President Trump's tariff wars.*

*Everything's nuts. Do you think you know, I was on the all in podcast the other day and they were talking about these chips, **these NVIDIA chips** and how what's interesting is people are setting up because we have these export controls that don't allow us to send certain chips to China because they're able to manipulate them and then become like the world's largest semiconductor producer. But now all these fun fake companies are starting like booting or Cambodia and they're buying the chips or Singapore. And then they all get back to China.*

*US and China trade war has been escalating on Monday, the White House informed in video that they were putting an indefinite export restriction on **Nvidia's H20 chips** to China. It was designed actually to comply with these export restrictions on AI chips.*

Well, much of that is dependent on OpenAI continuing to buy services from Core Weavers. Core Weavers sees preferential access to **Nvidia's GPUs** though **Nvidia** kind of denies that. It makes up billions of dollars of **Nvidia's** revenue. Core Weavers then takes those GPUs, and then they raise debt using the GPUs as collateral, as well as customer contracts. Then they use the money they've raised to buy more GPUs from **Nvidia**.*

***Nvidia** had paid about a million dollars to attend a Mara Logo dinner. At that dinner, he apparently convinced either Trump or somebody around Trump not to put export licenses on those H 20 chips that **Nvidia** had developed specifically to be liable with these X work controls, me able to ship to China, approximately 5.5 billion dollar market segment for Nvidia. Well, it came out overnight that as a result of the tariffs and despite some of the previous promises that may have made to **Nvidia**, the United States would be slapping export controls on those H 20 chips.*

*We talked more about these export restrictions on yesterday's episode, so go check that out if you missed it. These export restrictions are expected to cause **Nvidia** and AMD billions of dollars in lost sales, and that's why both their stocks were down around 7% yesterday, dragging the rest of the market down with it. One of the few things that might be more influential than **Nvidia** are comments from FedCheer Jerome Powell.*

*In markets news today shares of **Nvidia** fell more than 6% in off-hours trading after **the chip maker** said it would take a 5.5 billion dollar hit on its quarterly earnings as it disclosed that the U.S. will now require a license. For exporting the company's H20 processors to China and other countries.*

*Now again, some of this looks like favoritism. It looks like some of the big companies that President Trump has been working closely with companies like Apple or **Nvidia**. They're partnering with Foxconn to do the manufacturing.*

*Trump this month. This week, **NVIDIA** said it'll build two new supercomputer factories in Texas. There are such facilities in the United States. Most of their manufacturing is currently in Taiwan. Chinese companies have been buying up in video products in case of a U.S. ban in China as one of **NVIDIA's** biggest markets.*

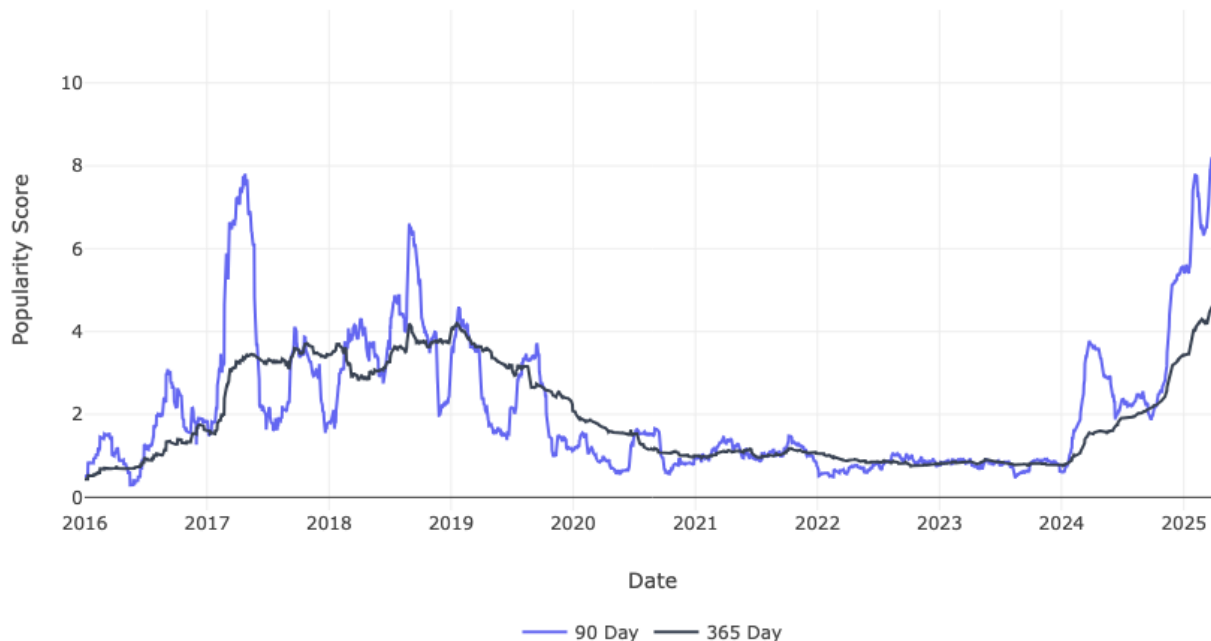

And they're threatening to choke off the supply of components to central automakers, aerospace, manufacture, **semiconductor companies**, and military contractors around the world. ## 3. Deported, deportation, deport, asylum

Discussions on deportation revolved around the specific case of Kilmar Ábrego García, with commentators offering their views on both the case and current U.S. immigration policies.

*And I don't see anyone in the White House saying, oh dear, what is this going to do for America's long-term security? They're thinking about what gets Maga happy now. It's so short-term, this administration. It's short-term on the tariffs. It's short-term. It's even short-term on immigration and **deporting**, if they might ever manage to do it, millions of people who are working in the country who are undocumented because the American economy depends on those people. Point to me, the long-term thing that Donald Trump is doing. That has any kind of long-term consequences in terms of it.*

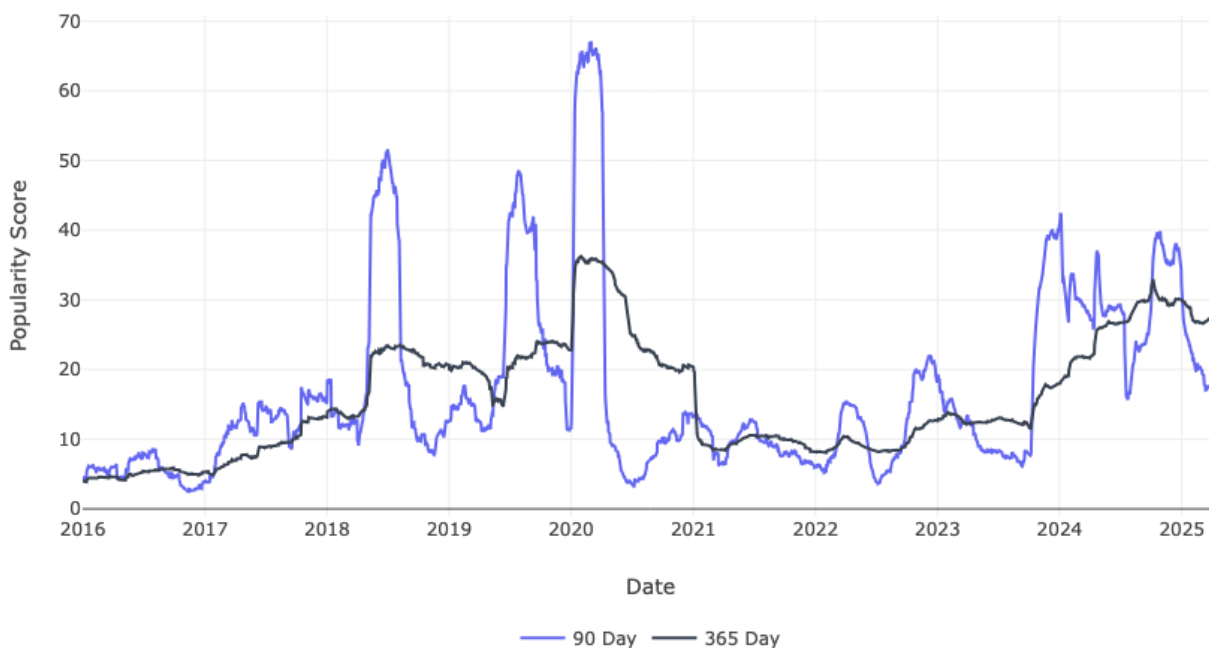

Iran and its nuclear program received increased attention this week as the U.S. and Iran continued their nuclear deal negotiations.

### 2025-04-19: Morning Wire

The Trump administration is aggressively pursuing the full dismantling of **Iran's nuclear program**, starting the first direct talks with the regime since 2018, with one sit-down already on the books and another on the docket. The Israeli attack would have required significant American involvement, and Israel hoped that the U.S. was on board. There were some signs that was the case. The Pentagon had already moved some aircraft carriers and bombers into the region.

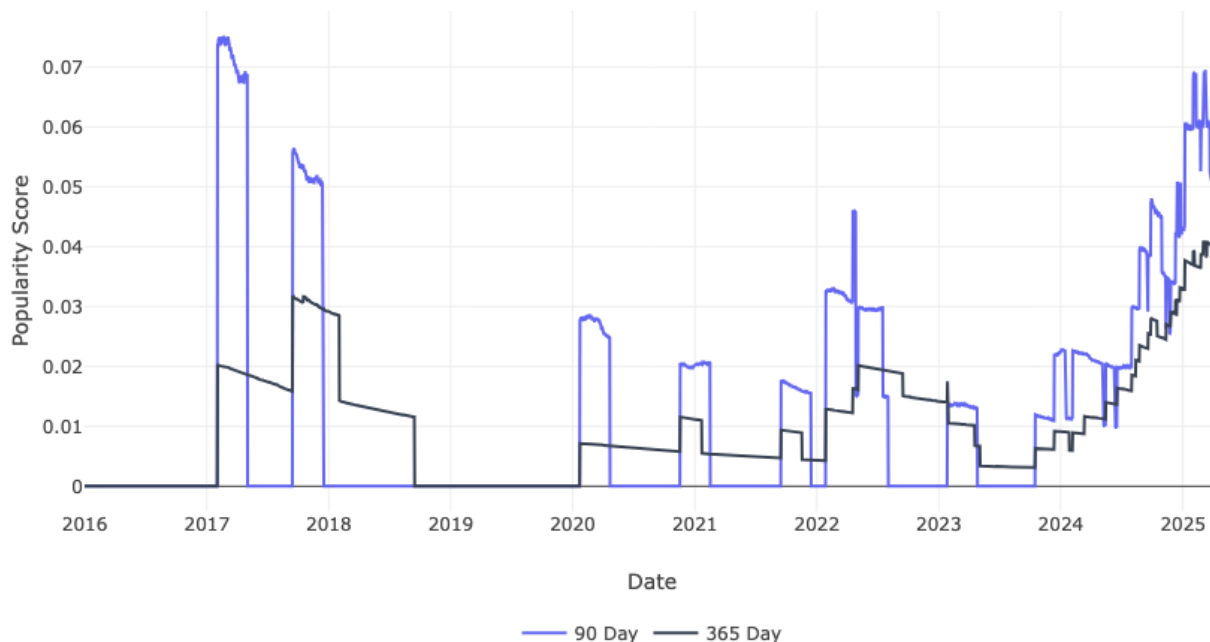
